




Fig. 1 - Derating Diagram





Fig. 2 - Test Pulse Diagram for Sample Test According to DIN EN 60747-5-2 (VDE 0884); IEC 60747-5-5

Fig. 3 - Test Circuit, Non-Saturated Operation





Fig. 4 - Switching Times
