




Fig. 9 - On-State Voltage Characteristics





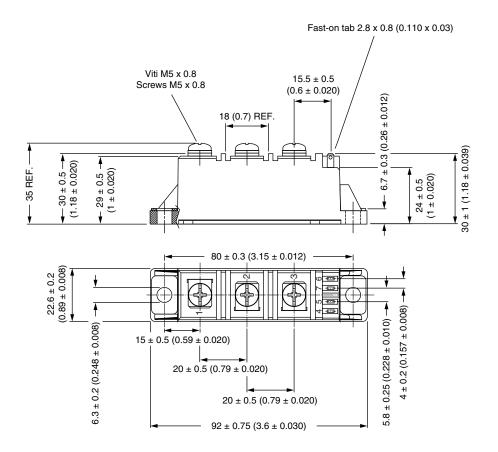
