






Fig 4. Transient thermal impedance from junction to mounting base as a function of pulse duration







Fig 5. Drain-source on-state resistance as a function of gate-source voltage; typical values





Fig 6. Input and reverse transfer capacitances as a function of gate-source voltage; typical values





Fig 7. Forward transconductance as a function of drain current; typical values





Fig 8. Output characteristics: drain current as a function of drain-source voltage; typical values





Fig 9. Transfer characteristics: drain current as a function of gate-source voltage; typical values





Fig 10. Sub-threshold drain current as a function of gate-source voltage





Fig 13. Drain-source on-state resistance as a function of drain current; typical values






Fig 14. Gate charge waveform definitions

Fig 16. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values





Fig 17. Source current as a function of source-drain voltage; typical values
