### 1. General description

The 74LVC1G02 provides the single 2-input NOR function.

Input can be driven from either  $3.3\ V$  or  $5\ V$  devices. These features allow the use of these devices in a mixed  $3.3\ V$  and  $5\ V$  environment.

Schmitt-trigger action at all inputs makes the circuit tolerant for slower input rise and fall time.

This device is fully specified for partial power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.




# 5. Functional diagram








Fig. 11. Package outline SOT753 (SC-74A)




Fig. 12. Package outline SOT886 (XSON6)




Fig. 13. Package outline SOT891 (XSON6)




Fig. 14. Package outline SOT1115 (XSON6)




Fig. 15. Package outline SOT1202 (XSON6)




Fig. 16. Package outline SOT1226 (X2SON5)
