18-bit universal bus transceiver with 30  $\Omega$  termination resistor; 3-state

## 1. General description

The 74ALVCH162601 is an 18-bit universal transceiver featuring non-inverting 3-state bus compatible outputs in both send and receive directions. Data flow in each direction is controlled by output enable ( $\overline{OEAB}$  and  $\overline{OEBA}$ ), latch enable (LEAB and LEBA) and clock (CPAB and CPBA) inputs. For A-to-B data flow, the device operates in the transparent mode when LEAB is HIGH. When LEAB is LOW, the A data is latched if CPAB is held at a HIGH or LOW logic level. If LEAB is LOW, the A-bus data is stored in the latch/flip-flop on the LOW-to-HIGH transition of CPAB. When  $\overline{OEAB}$  is LOW, the outputs are active. When  $\overline{OEAB}$  is HIGH, the outputs are in the high-impedance state. The clocks can be controlled with the clock-enable inputs ( $\overline{CEBA}$  and  $\overline{CEAB}$ ).

Data flow for B-to-A is similar to that of A-to-B but uses  $\overline{OEBA}$ , LEBA and CPBA.

To ensure the high impedance state during power up or power down,  $\overline{OEBA}$  and  $\overline{OEAB}$  should be tied to  $V_{CC}$  through a pullup resistor; the minimum value of the resistor is determined by the current-sinking/current-sourcing capability of the driver.

The 74ALVCH162601 is designed with 30  $\Omega$  series resistors in both HIGH or LOW output stage.

Active bus-hold circuitry is provided to hold unused or floating data inputs at a valid logic level.

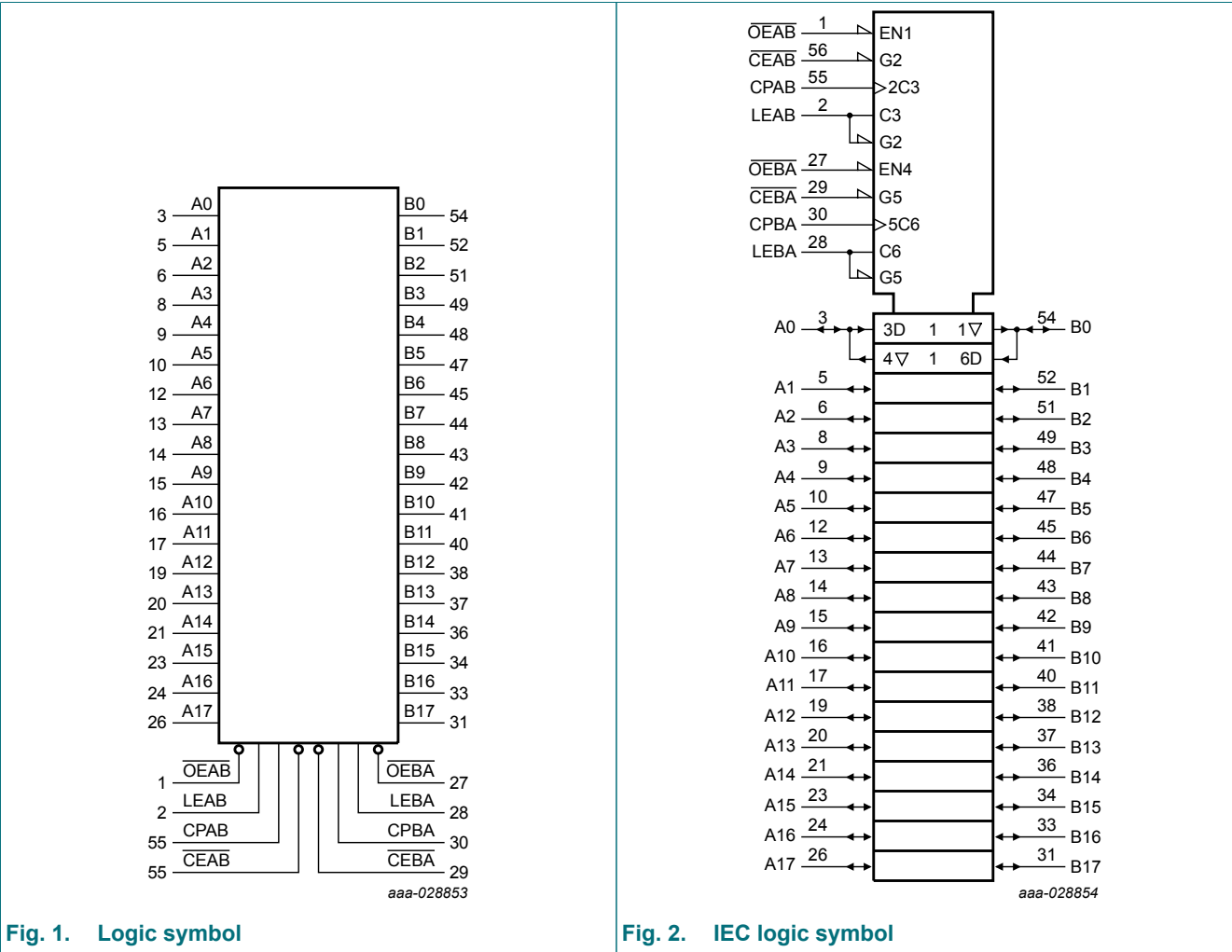


Fig. 1. Logic symbol

Fig. 2. IEC logic symbol

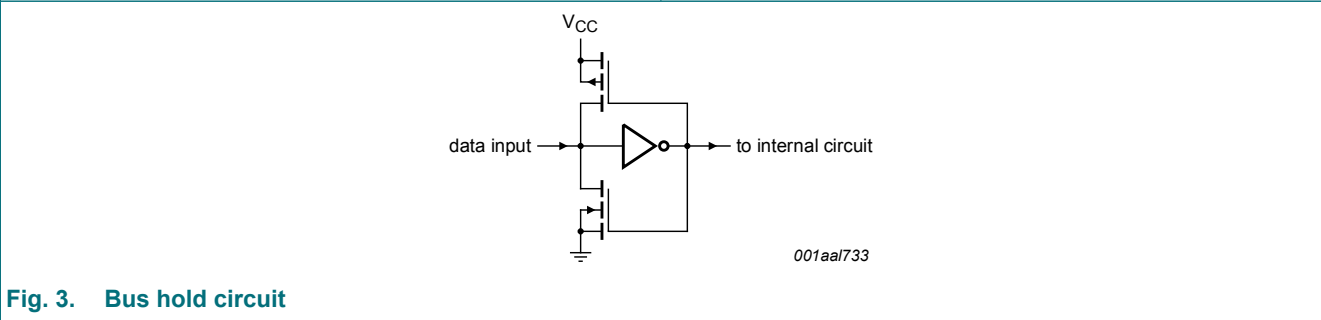
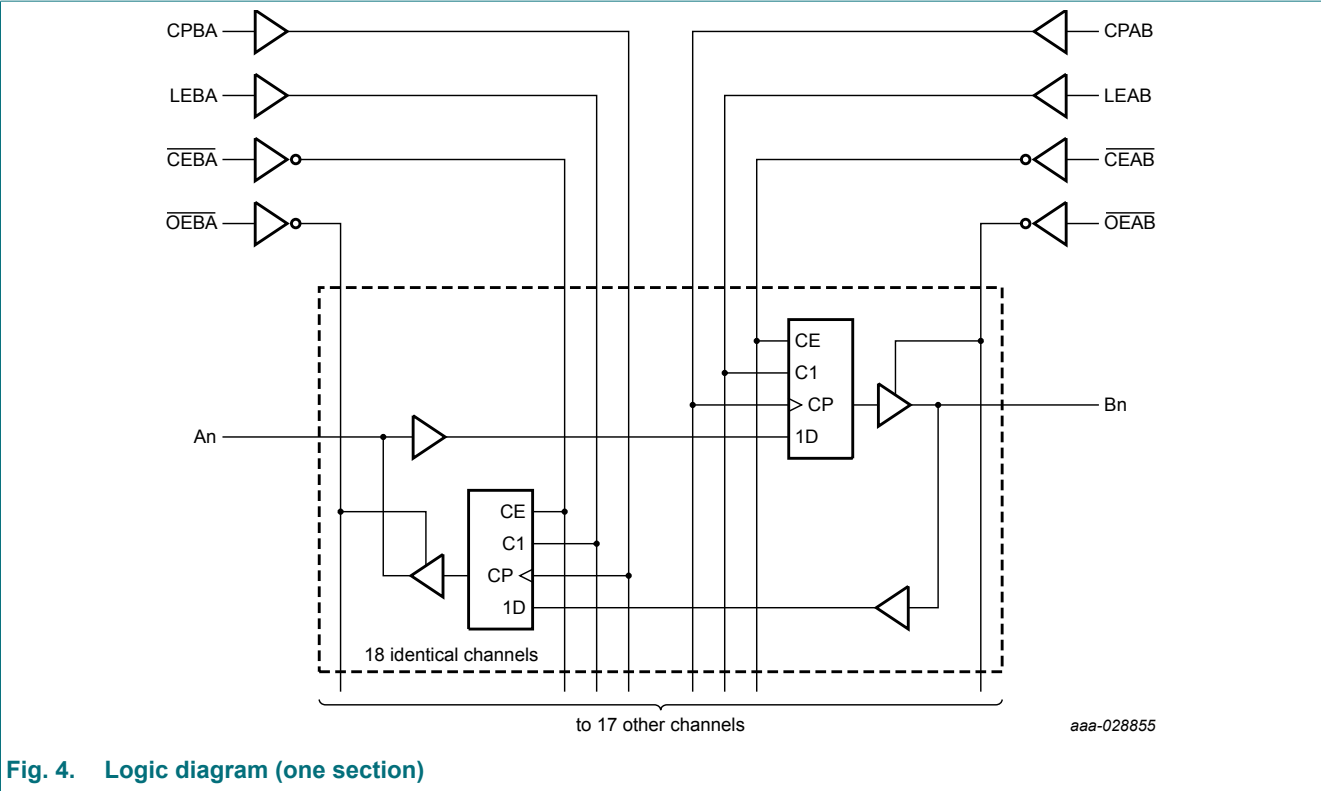


Fig. 3. Bus hold circuit

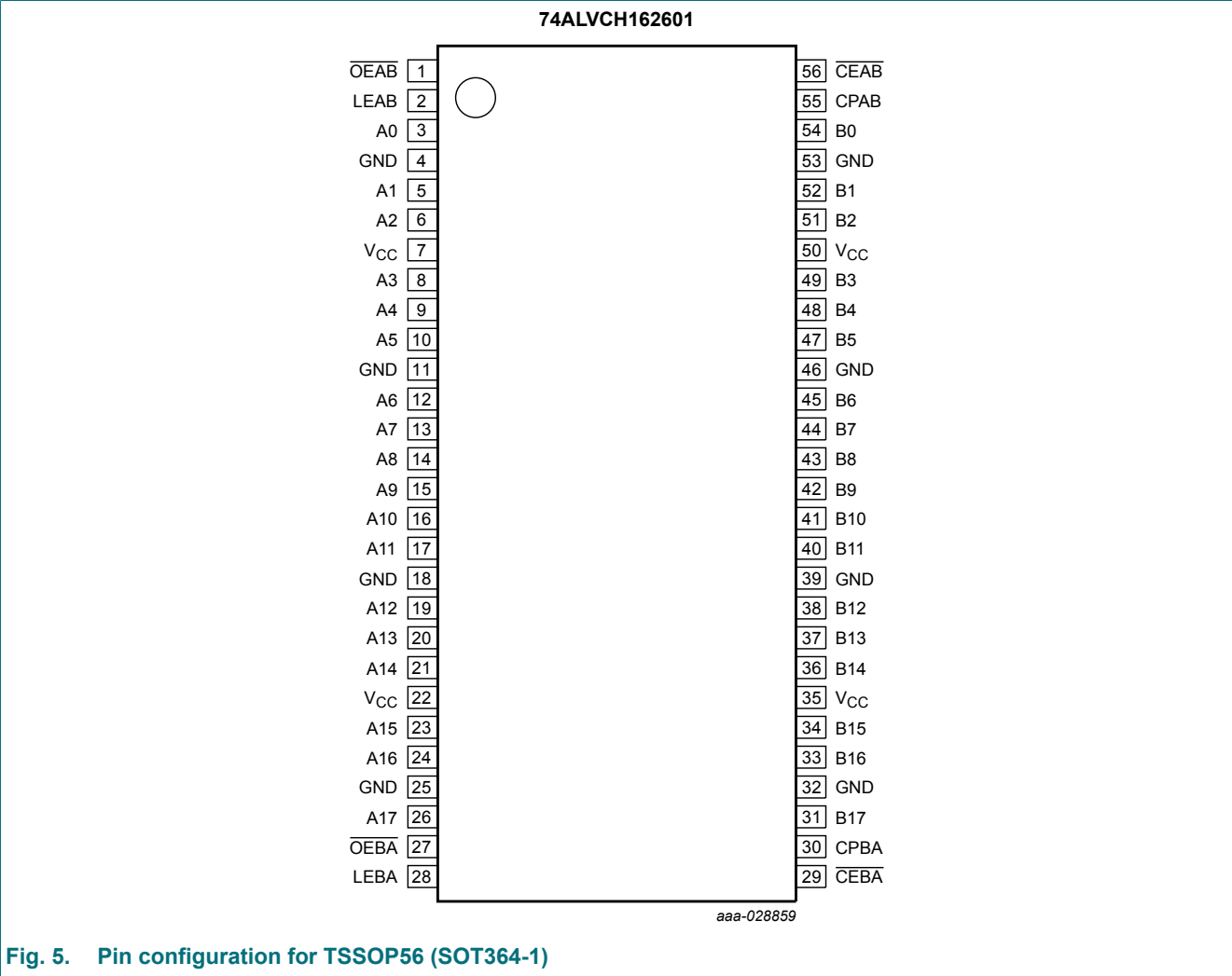


Fig. 5. Pin configuration for TSSOP56 (SOT364-1)

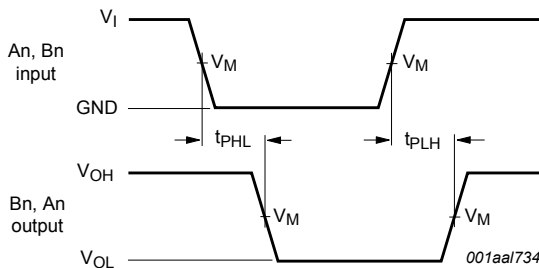

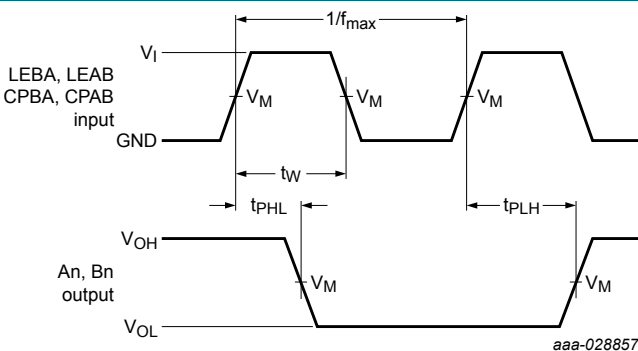

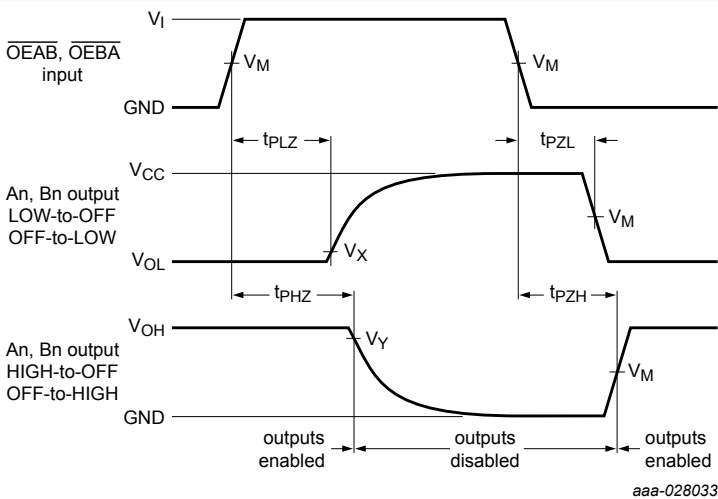

Fig. 8. 3-state enable and disable times.

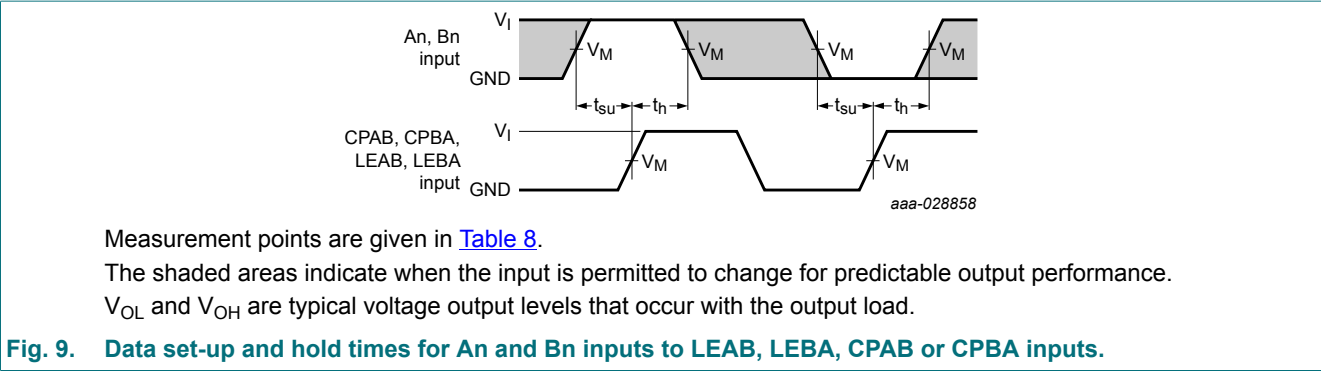

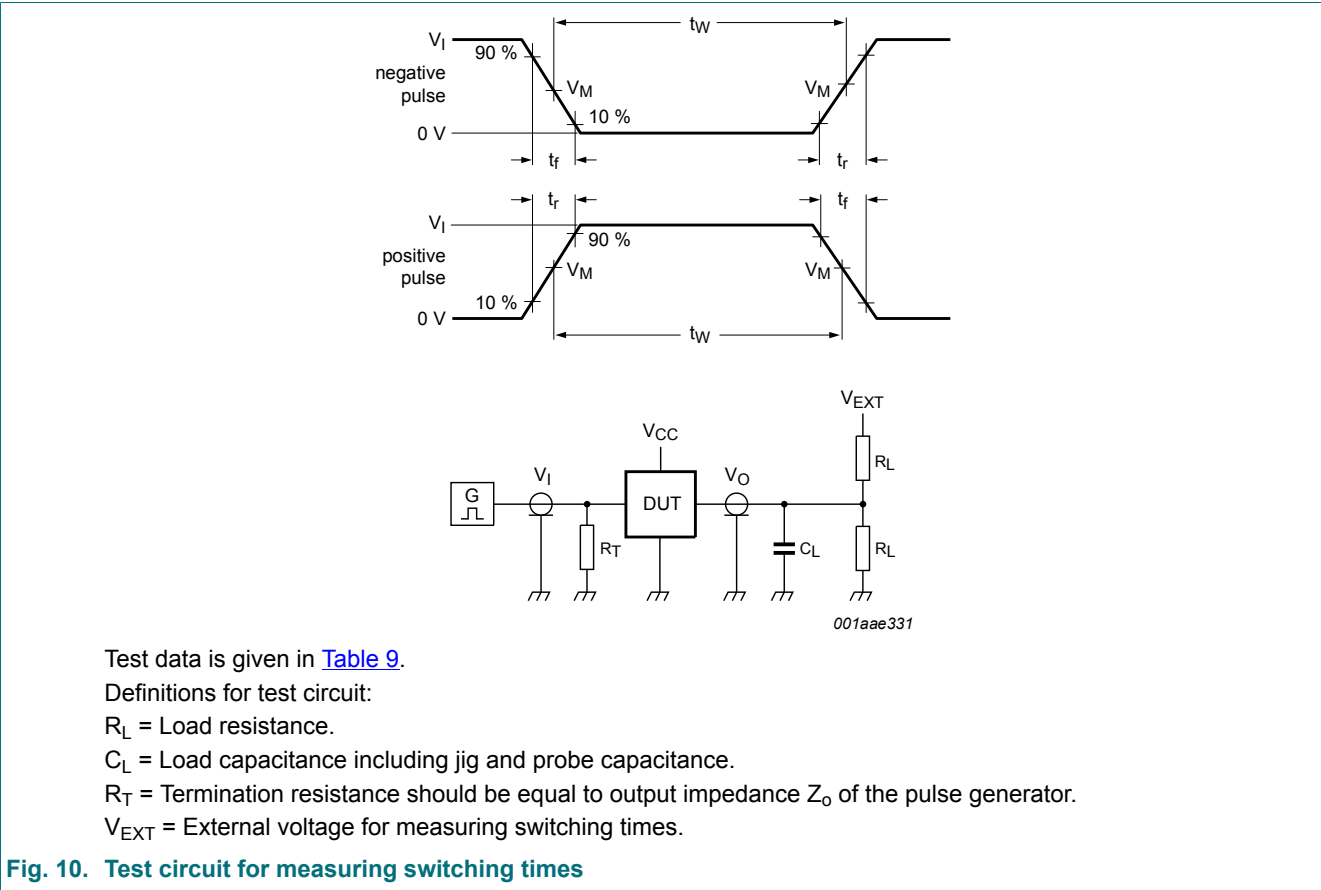

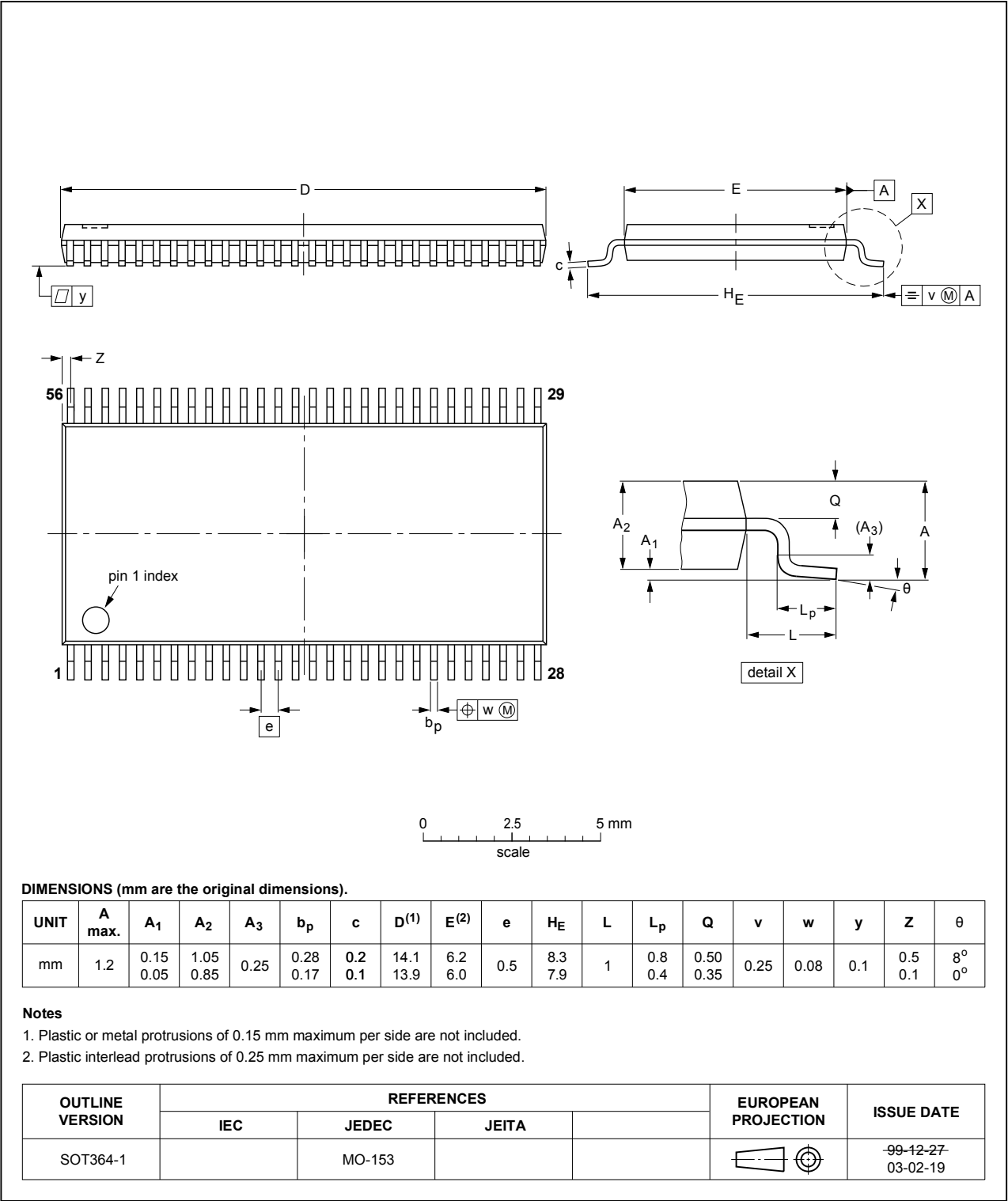


Fig. 11. Package outline SOT364-1 (TSSOP56)
