

Description

The 74AHCT86 provides provides four independent 2-input exclusive OR gates with standard push-pull outputs. The device is designed for operation with a power supply range of 4.5V to 5.5V.

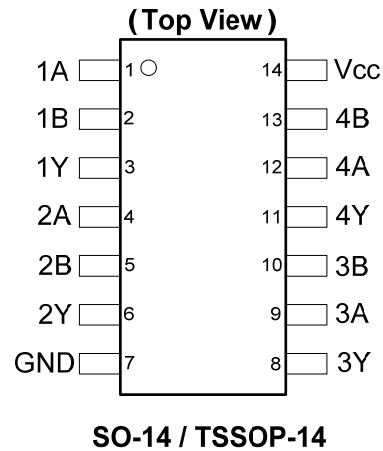
The gates perform the Boolean function:

$$Y = A \oplus B \text{ or } Y = \overline{A}B + A\overline{B}$$

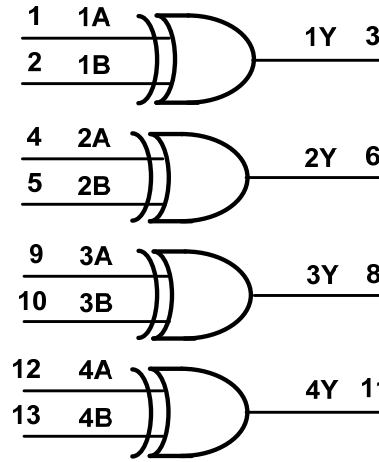

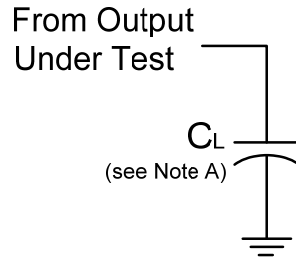

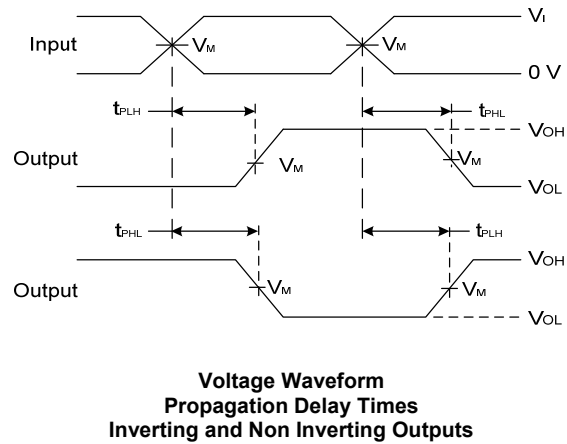
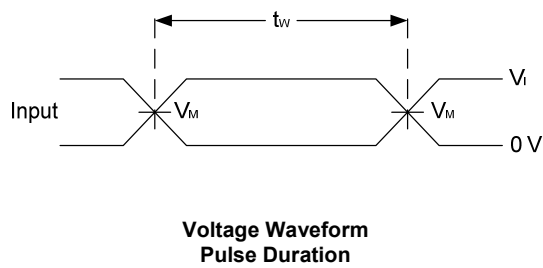
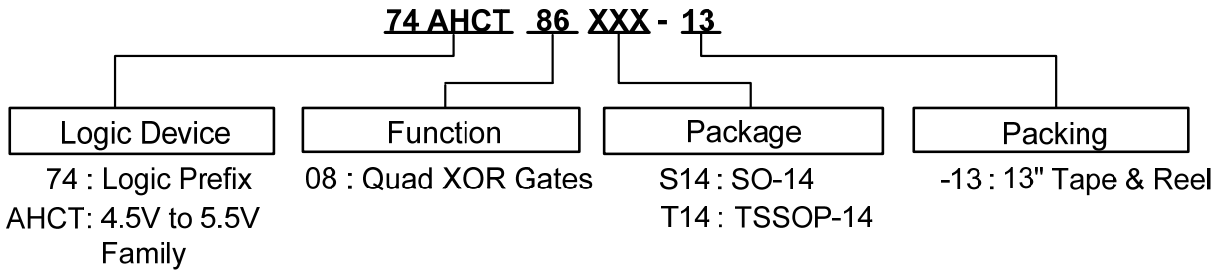


Figure 1 Load Circuit and Voltage Waveforms

 - D. t_{PLH} and t_{PHL} are the same as t_{PD}

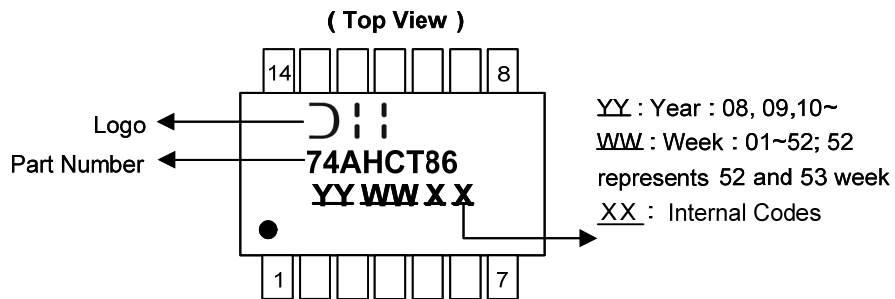

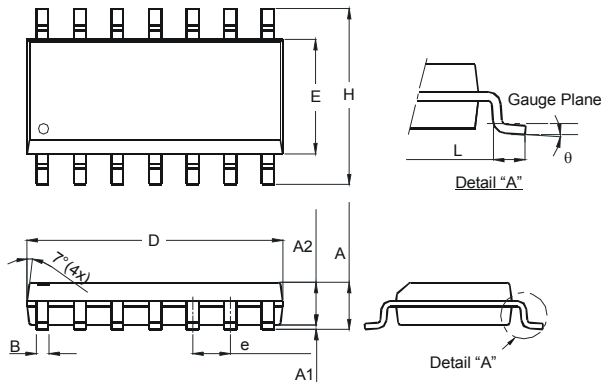

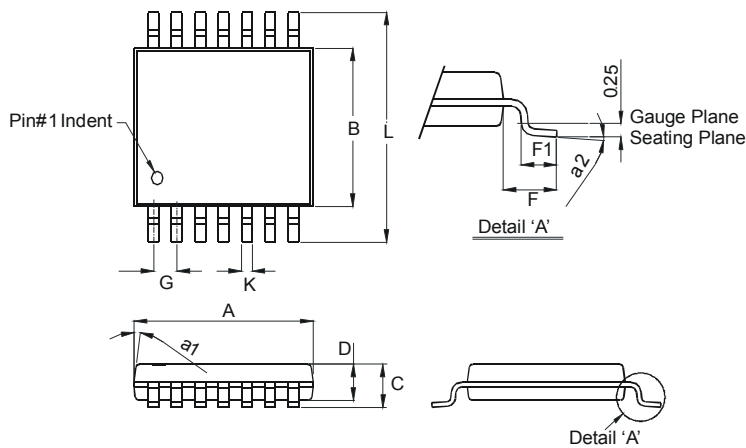

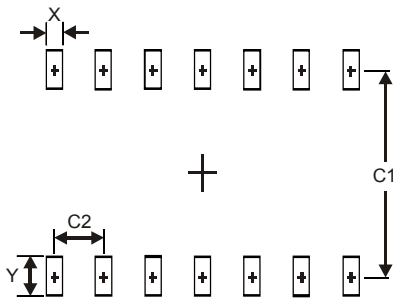
