



Fig.1 Ground Emitter Propagation Characteristics


Fig.2 Typical Output Characteristics



COLLECTOR TO EMITTER VOLTAGE : V_{CE} [V]


Fig.3 DC Current Gain vs. Collector Current (I)

Fig.5 Collector-Emitter Saturation




Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II) Ta = 25°C SATURATION VOLTAGE : V_{CE(sat)} [V] Pulsed COLLECTOR-EMITTER 0.1

Fig.7 Base-Emitter Saturation Voltage vs. Collector Current






Fig.8 Gain Bandwidth Product vs. **Emitter Current**




