




#### On-Resistance vs. Drain Current








On-Resistance vs. Junction Temperature Drai




**Drain Source Breakdown vs. Junction Temperature**

On-Resistance vs. Gate-to-Source Voltage






#### Safe Operating Area



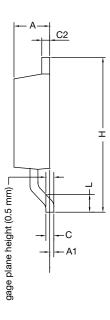
