Schematic:



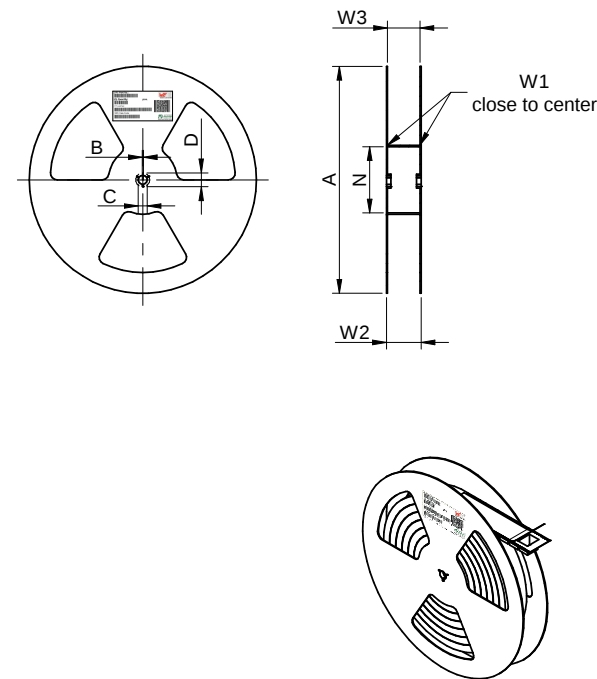
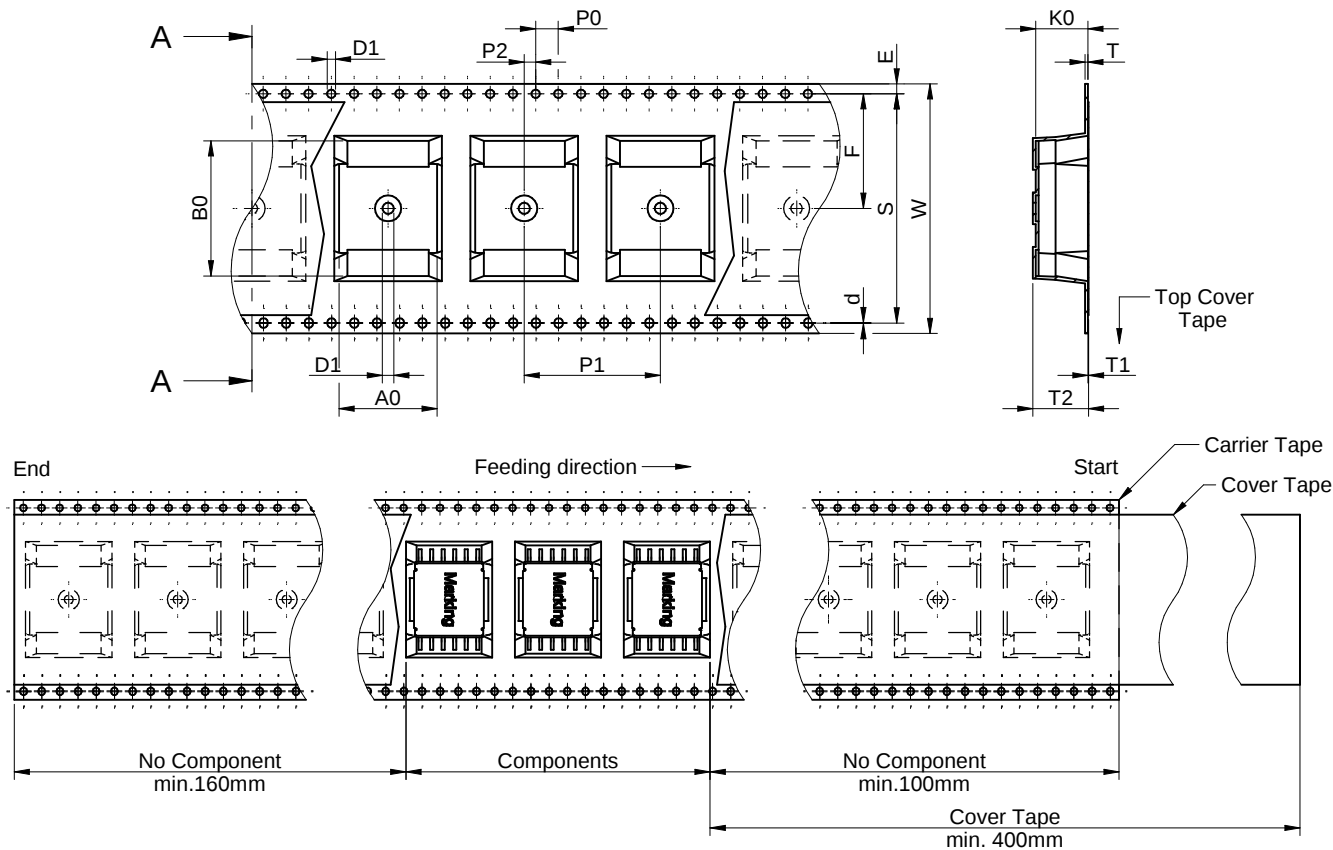
