Description

The SMV1245 series surface-mount varactor diodes are designed for very low series resistance applications such as RF and microwave VCOs.

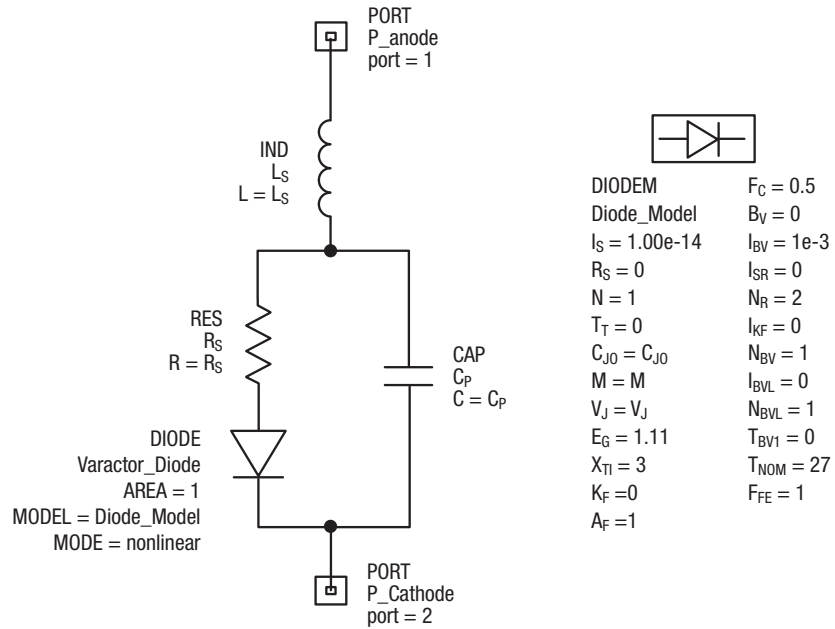


Figure 2. SPICE Model

The SMV1245 series packaging and marking information is shown in Table 1. The absolute maximum ratings of the SMV1245 series are provided in Table 2. Electrical specifications are specified in Table 3. Figure 1 shows the typical performance of capacitance versus reverse voltage. The SPICE model for the SMV1245 series is shown in Figure 2 and the associated model parameters are provided in Table 4. The relationship between voltage and capacitance for the SMV1245 series is shown in Table 5.

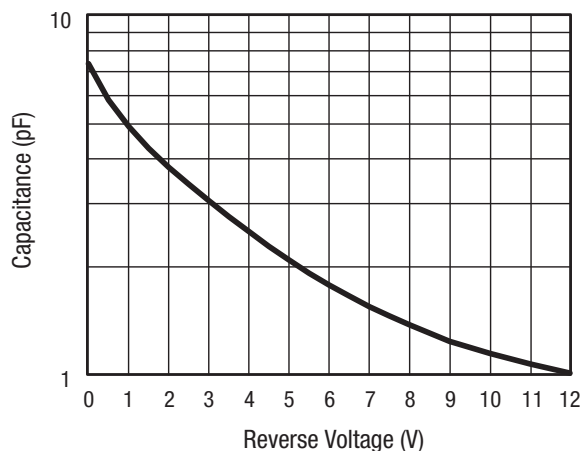

**Figure 1. Capacitance vs Reverse Voltage @ 25 °C**

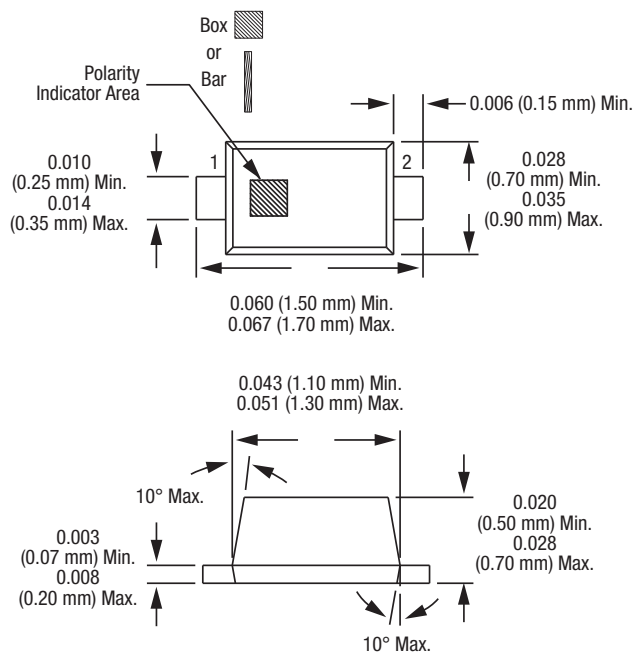
Package and Handling Information

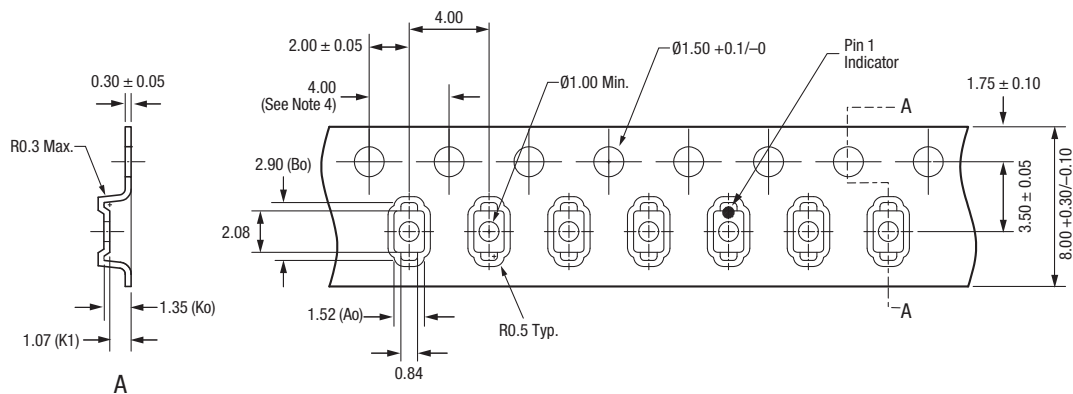
Figure 4. SC-79 Tape and Reel Dimensions

Package dimensions for the SMV1245 SC-79 package are shown in Figure 3, and tape and reel dimensions are provided in Figure 4. Package dimensions for the SMV1245 SOD-323 package are shown in Figure 5, and tape and reel dimensions are provided in Figure 6.

Instructions on the shipping container label regarding exposure to moisture after the container seal is broken must be followed. Otherwise, problems related to moisture absorption may occur when the part is subjected to high temperature during solder assembly.

The SMV1245 series is rated to Moisture Sensitivity Level 1 (MSL1) at 260 °C. It can be used for lead or lead-free soldering. For additional information, refer to the Skyworks Application Note, *Solder Reflow Information*, document number 200164.

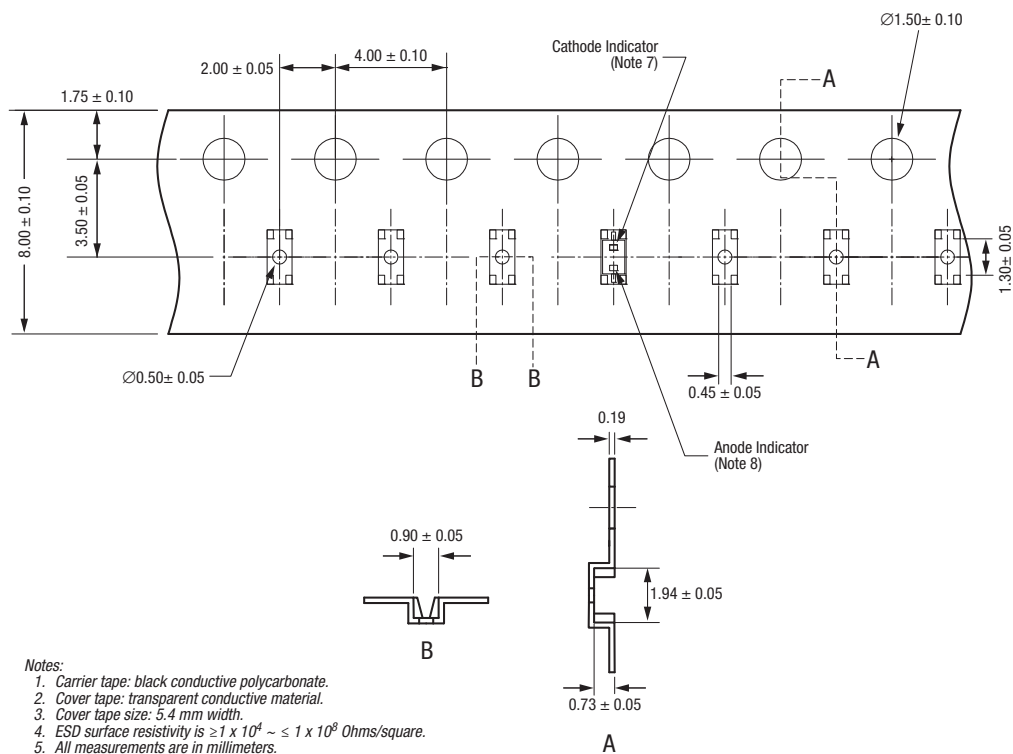
Care must be taken when attaching this product, whether it is done manually or in a production solder reflow environment. Production quantities of this product are shipped in a standard tape and reel format.

Figure 3. SMV1245 Series SC-79 Package Dimensions

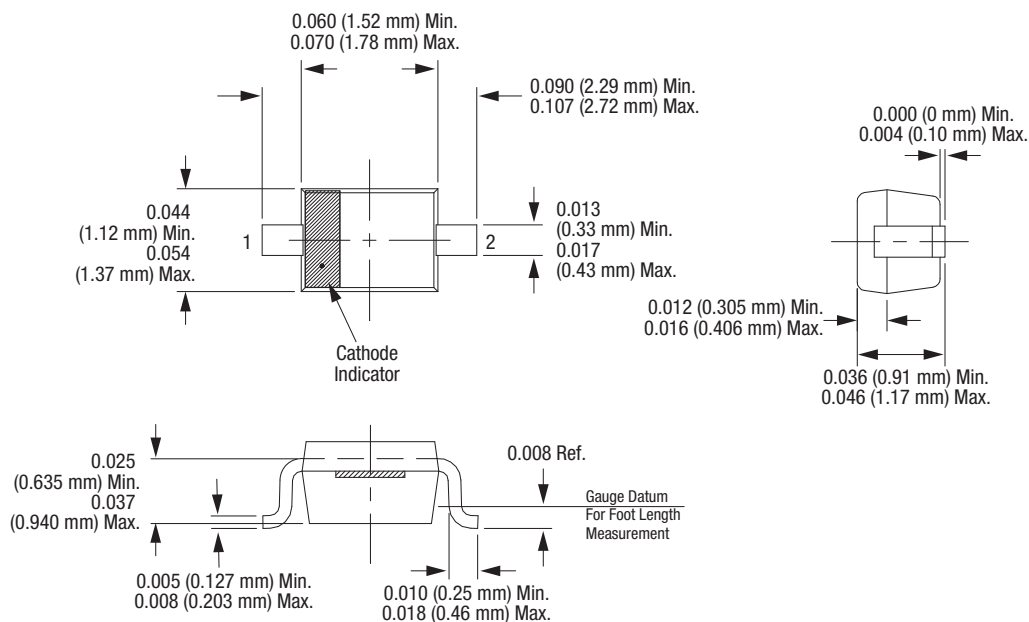
