Differential Mode

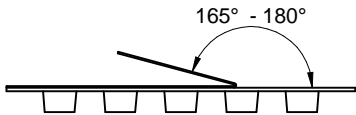

### Soldering:



### Storage Conditions:


