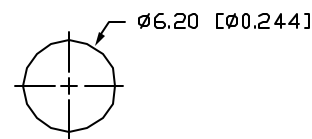


PANEL CUTOUT



NOTES:

1. SSL-LX3054SR, RED LED. TRIM LEADS TO 5mm.
2. SSI-LXR1612, CHROME HOUSING.
3. LXP-WA-3612, RUBBER GASKET.
4. SOLDER WIRE TO LEADS.
5. SSH-LXH1612BSG, BUSHING, INSERT AND CRIMP.
6. ANODE: 26 AWG, STRANDED, RED INSULATION. CUT 157mm LONG, STRIP ENDS 2mm & 9.5mm.
7. CATHODE: 26 AWG, STRANDED, BLACK INSULATION. CUT 157mm, STRIP ENDS 2mm & 9.5mm.
8. ASSEMBLE IN ORDER: LED, SILICON, THEN BUSHING.
9. WATER RESISTANT PER NEMA STANDARD 250 SECT. 6.7.
