Logic level gate drive N-channel enhancement mode MOSFET in LFAK56 package optimized for low $R_{DS(on)}$. Low I_{DSS} leakage even when hot, high efficiency and high current rated to 300 A, optimized for DC load switch and hot-swap applications.











Fig. 7. Output characteristics; drain current as a function of drain-source voltage; typical values




Fig. 8. Drain-source on-state resistance as a function of gate-source voltage; typical values




Fig. 9. Transfer characteristics; drain current as a function of gate-source voltage; typical values




Fig. 10. Drain-source on-state resistance as a function of drain current; typical values




Fig. 11. Normalized drain-source on-state resistance factor as a function of junction temperature




Fig. 12. Gate-source voltage as a function of gate charge; typical values






Fig. 13. Gate charge waveform definitions

Fig. 15. Source-drain (diode forward) current as a function of source-drain (diode forward) voltage; typical values




Fig. 16. Reverse recovery timing definition




Fig. 17. Package outline LPAK56; Power-SO8 (SOT669)





Fig. 18. Reflow soldering footprint for LPAK56; Power-SO8 (SOT669)
