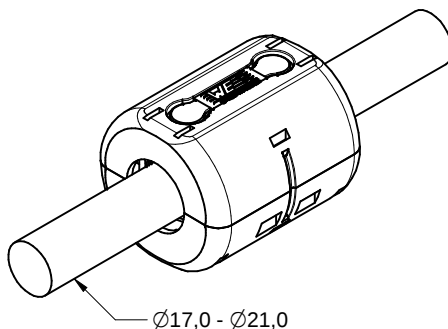

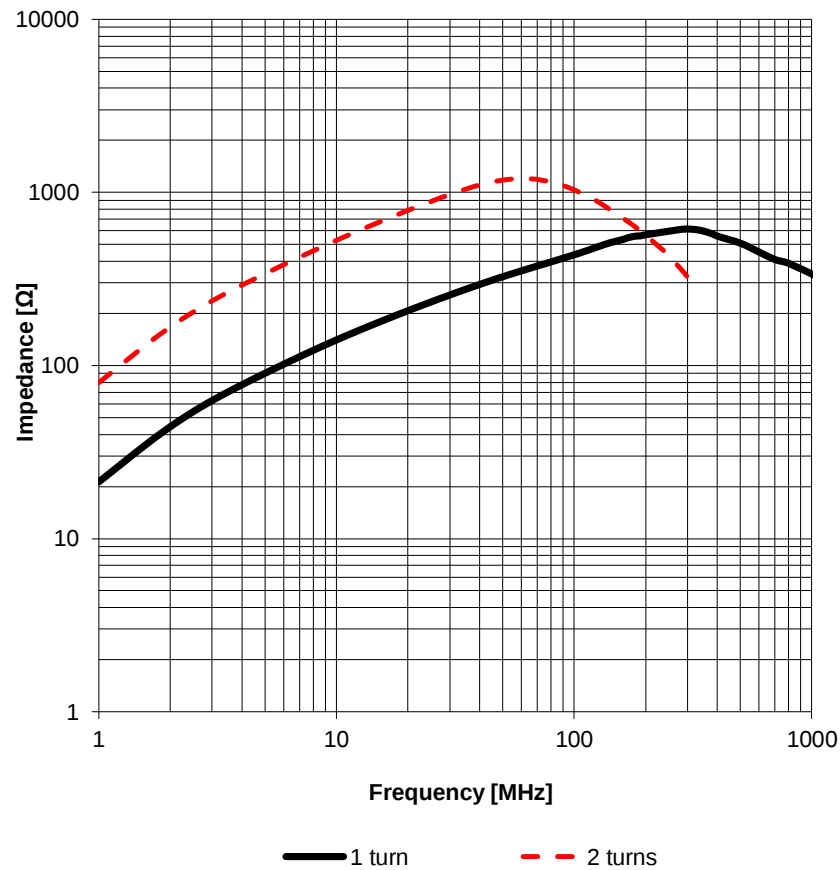


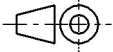

If not, the products are losing their humidity. In this case you can re-condition the components according to the internal standard WE1581 to ensure the necessary humidity in the plastic.

To ensure the operating mode of the product, the ambient temperature at processing (when the part will be mounted on the cable) has to be in the range of 15 to 25 °C. Before mounting, the part should be stored for one hour in this condition. The responsibility for the applicability of customer specific products and the use in a particular customer design is always within the authority of the customer. All technical specifications for standard products do also apply to customer specific products.

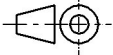
Direct mechanical impact to the product and the forcible closing of this shall be prevented as the ferrite material of the ferrite body or the plastic housing could flake or in the worst case it could break.

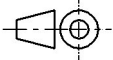
