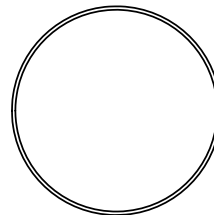
1. **MOUNTING:** Mounts in a  $\phi .250 \pm .002$  [ $\phi 6.35\text{mm} \pm .05$ ] panel hole on .375 [9.5mm] centers. Panel thickness .031 [.8 mm] to .250 [6.35mm]. Panel hole should be deburred, but not chamfered.
2. **ASSEMBLY:** Insert lens through panel hole, (for thin panels less than .188 [4.75mm] thick, slide SPC 125 spacer on back of lens), and insert LED into lens.
3. **MATERIAL:** Polycarbonate, UL 94-V2
